## **Acceptable Donors:**

- The donor may NOT be, or have any affiliation with, the builder, the developer, the real estate agent, or any other interested party to the transaction.

## **Required Documentation**

- A gift letter, provided by your lender, signed and dated by the donor and borrower.
- A cashier's check made payable to the borrower AND the Title Company with the donor listed as the remitter.
